President's Report

The 22/23 cricket season was another very good year for the club. On-field, the firsts, seconds and thirds men's teams, and the women's team all made finals, and four out of the eight junior teams made finals. The season saw the club in the new clubrooms for the full season and the new facilities are making a huge difference to the social functions and retention of players. The club has a strong committee and is in a healthy financial position.

Although it was disappointing not to get a flag out of the teams that made finals, we continue to put ourselves in contention each year. The firsts had a good season, recovering to win three out of four two-day games outright. The seconds and thirds both finished on top of the ladder, which proves there is plenty of depth at the club. The fourths performed well in the Churches competition and debuted several U15 players during the season. The women's team did extremely well to make the grand final after being promoted to division one mid-season. We had several players win competition trophies: Sakun Hettiyahandi – best player VTCA Division 4; Nick Keating – best player VTCA Division C4; and Jonathan Rayson-Hill – batting average WSCCCA Division 12.

The club fielded eight junior teams this season, including two girl's teams. For the first time in a few years, we fielded combined teams at U17 and U11 age groups. We had four teams make the finals, with the U13s boys progressing to the grand-final. We had two junior players win competition trophies: Kaelen McGee won the batting award in the U11A Fri South competition and Curtis Lamont won three awards across the U13/15 grades.

I would like to thank all our junior coaches – they did a great job developing players and making sure they had fun. Our Friday night Blasters program had 30 participants and it continues to be a good source of players for our U11 teams. Thanks go to Ben Rogers, Peta Ginnane, Dave Presley, Chris Keating, Cam Jackson, Carys Nolan and Kylah Ginnane, who helped run the Blasters each Friday night.

There were some very good social functions run through the year, including the trivia night, the ladies wine day, past players day and the big draw. These functions were well attended in the new rooms. One area for improvement is to get a full social committee up and running in 23-24. This will help run more functions and generate some new ideas for functions. I would like to thank all sponsors - a complete list of sponsors is included in the annual report. Please give their businesses your full support.

The club is fortunate to have a strong committee who are committed to fulfilling their roles, my thanks and appreciation to Lee Smart (Treasurer), Ben Rogers (Secretary & Director of Junior Cricket), Peta Ginnane (Vice President), Ross Thomasson, Mike Stowe, Lorey Bentley and Angus Raiskums. Thanks also to the people who helped when asked during the season. We would welcome any additional volunteers to be on the committee. We can find you a role for you without it being a great imposition on your time.

Going forward, I hope we can continue to capitalise on the new clubrooms by expanding our social functions to include partners, past players, parents and supporters. We want to see more people at the club watching our senior and junior games. The core of our senior men's playing list is made up of players from our junior programme, hopefully this continues with the U15s coming through now. Our U16 girls will now doubt become ready to play senior women's cricket in the future.

Finally, I want to thank the committee, coaches, players, sponsors, and supporters. Our vision is to be a successful club by providing a welcoming environment to the whole community. We want to be able to give people an opportunity to play cricket in a fun and learning environment. The club has taken great strides in recent years which sets us up for the future.

Treasurer's Report

The club has finished the year with a total cash balance of \$79,392, made up as follows:

This represents a cash loss of \$14,674. Although it's a significant dip in our Cash Balance, it is something we have planned for in regards to requirements for our new clubrooms and updating our equipment. One off items this season include new covers, mower, covers trolley, barbecue and various other items for the kitchen plus the Out the Locker Room sessions. In the last two seasons we have spent 60k on new equipment, future proofing our club. A significant amount of the equipment bought had already been covered by grants received over the last couple of seasons.

If you take out the one-off items, we may an operating profit of \$3,031 which is a good result considering the increase in a number of expenditure items. After the last two disrupted seasons we had a near normal season although we lost a month of cricket due to rain in October. Our bar turnover at 34k was the highest for many years with a margin of 97%. This takes into account where we didn't charge for food on several occasions. We've introduced new products in our range and are only too happy to provide more options upon request and demand.

We are appreciative of all our sponsors which makes a massive difference to the financial stability of the club. Thanks go to Ben who is responsible for obtaining the bulk of our sponsors. Thanks must go to all our sponsors, hopefully our members, supporters and families return the favour and support our sponsors where they can.

Going forward, given our financial position we will look at ways of maximising the return to our members. This season every player, junior and senior were issued a playing top without charge. Our bar prices and membership fees are much lower than most other clubs. Opposition players often remark on how cheap our prices are.

Financially, the continued common-sense approach to setting fees and looking to revenue streams like sponsorship and fundraising events to do the operational grunt work, has kept us in a really good position. We've managed to maintain a healthy amount in reserves and still fund things like a new mower, covers and covers trolley, and the new barbeque.

There was a bit of an up-tick in sponsorship revenue, which probably puts us in the high performer category in this regard when compared to other clubs of similar stature. We have enjoyed some strong and consistent support from a terrific group of sponsors in recent years. They are all listed earlier on in this report so I won't put them all here, but I really encourage all members to keep their support in mind next time they're in need of a bathroom renovation, a real estate agent, groceries or some new specs. Seek them out and show your appreciation, because their support of us is directly linked to our support of them.

We were a bit lower on the grants side of things this summer, an area that has served us well in recent years. Grant proposals are quite time-consuming and I must admit that I just did not have the time to spend on too many of them this season. Grants are also quite cyclical, most only allow an application every few years, so hopefully we see our performance return to normal again in 2023/24.

The Committee did a great job organising and delivering some terrific social events this season. The first Trivia Night in the new pavilion, another well-attended and really enjoyable Past Players Day and a successful Big Draw were all highlights. These, along with the other events held this year, contributed to our financial position, but also provided an opportunity for social interaction off the field. In future, it should be a collective priority to make sure that all parts of the club, seniors/juniors, male/female, are involved and that we are delivering events which appeal to all members. An emphasis should also be placed on engaging past players in next year's events, it's difficult to get everyone together but events are always a success when we do.

The junior program remains strong and we are starting to see some of our juniors coming though and performing well in both the men's and women's senior competitions. The future is looking good, with strong numbers in Cricket Blast and a plan to increase our reach in local schools. Keats does a great job running the show on Friday nights, ably supported by Chris, Dave, Cam, Carys and Kylah with Darren and Peta regularly helping with the raffle and canteen.

We really have positioned ourselves in recent years as a well-respected community club. We continue to punch above our weight when it comes to club management and the work being done behind the scenes is coming through in our on-field performances. The club is supported by a small (too small, really) but dedicated group of volunteers, who work tirelessly to keep the place running. My thanks to all of them. Special thanks to Mark; not many people get to see the effort he puts in, but let me tell you, it is astonishing.

I say it every year; how we operate, the way we portray ourselves on and off the field, and what we manage to achieve each season is something we should all be proud of. I'm certainly proud of it.

Looking forward to October already.
